O R D E R 20.09.2016

The petitioner Sri Indra Rongphar is present.

The Public Authority is represented by Sri Ananda Ch. Karmakar, SPIO cum Joint Director of Agriculture, Directorate of Agriculture, Khanapara and Sri Tulashi Gogoi, PIO, Office of the Executive Engineering (Agriculture), Diphu. He has submitted a Written Statement dated 07.09.2016 that RTI application was received in the office of the Directorate of Agriculture, Khanapara on 30.01.2016 and same was transferred to the District Agriculture Officer, Diphu and Executive Engineer(Agriculture), KAAC, Diphu on 05.02.2016. That the petitioner filed the First Appeal before the Executive Engineer, Agricultural Engineering, Diphu on 14.03.2016 and Complaint Petition was filed before the Commission on 16.06.2016.

The PIO, Office of the Executive Engineering, (Agriculture), Diphu has submitted a Written Statement that the office has not received any Fund Release Order from the Directorate of Agriculture, Khanapara, Assam under RKVY Scheme during the period 2008 to 2014-15.

The petitioner stated that he had sought for information only on total fund released for implementation of Schemes under RKVY to KAAC, Diphu with photocopies of Fund Release Order and would be satisfied if he receives photocopies of the Fund Release Order.

The SPIO cum Joint Director of Agriculture, Directorate of Agriculture, Khanapara present stated that he was not aware of the fund released under RKVY by the Directorate of Agriculture, Khanapara to the implementing Agency.

The Commissioner, therefore, directs the SPIO, Office of the Directorate of Agriculture to furnish the photocopies of Fund Release Order to the petitioner as sought for within 15 days from date of receipt of this order.

The Complaint Petition dated 16.06.2016 is disposed of.
