The petitioner Shri A.K. Laskar is present.

The Public Authority to be represented by the Block Development Officer, Dullavcherra Development Block, Karimganj is absent, but has intimated that since he has been engaged in election works, he is unable to attend the hearing today and has sent available documents through e-mail. He has enclosed a copy of letter dated 06.09.2016, wherein he has stated that information related to Anchalik Panchayat is available in the Block office, but the information sought for is voluminous in nature. As such the petitioner may collect the same from the office of the Block Development Officer, Dullavcherra. He has also stated that Gaon Panchayat Secretaries are the custodian of their records and funds are directly released to them by the Zilla Parishad. The information may be collected from the office of the G.P. Secretaries concerned.

The Commission, therefore, directs the petitioner to inspect the relevant records and documents in the office of the Block Development Officer, Dullavcherra Development Block, Karimganj and the concerned G.P. Secretaries within 15 days from the date of receipt of this order.

The Block Development Officer and G.P. Secretaries are also directed to allow the petitioner to inspect the relevant record and documents as above and allow him to take notes and photocopies of the documents sought for, free of cost, upto 20 copies and thereafter on payment of Rs. 2/- for every additional page of photocopy.

The Complaint Petition dated 06.06.2014 is disposed of.
