The petitioner Shri A.K. Laskar is present.

The Public Authority to be represented by the SPIO, Office of the Superintendent, Deorial Sr. Madrassa, Bodarpur, Karimganj is absent, but the Superintendent i/c, Deorial Sr. Madrassa, Bodarpur, Karimganj has submitted a Written Statement dated 04.09.2016 that RTI Petition was filed before the former Superintendent of the Madrassa and he had not received any communication from the Director, Madrassa Education, Assam. He also sought for permission to exempt him from being present for the hearing on 13.09.2016 fixed by the Commission due to Holy Idd-ul-Azha. He has also stated that information sought for by the petitioner is voluminous in nature and requested the Commission to direct the petitioner to collect the information from the office of the Superintendent i/c, Deorial Sr. Madrassa, Bodarpur, Karimganj.

On perusal of the RTI Petition dated 14.02.2014, it appears that the Application involves a huge volume of information relating to several categories of information for several years i.e. 2008-09 to 2014-15.

The Commission, therefore, directs the petitioner to inspect the relevant records and documents in the office of the Superintendent, Deorial Sr. Madrassa, Bodarpur, Karimganj within 15 days from the date of receipt of this order if he is interested to receive the information.

The Superintendent, Deorial Sr. Madrassa, Bodarpur, Karimganj is also directed to allow the petitioner to inspect the relevant record and documents as above and allow him to take notes and photocopies of the documents sought for, free of cost, upto 20 copies and thereafter on payment of Rs. 2/- for every additional page of photocopy.

The Complaint Petition dated 04.06.2014 is disposed of.
