<u>O R D E R</u> 04.10.2016

The petitioner Shri A.K. Laskar is present.

The Public Authority to be represented by the Office of the Block Development Officer, Bodarpur Dev. Block, Bodarpur, Karimganj is absent without any intimation. In view of the large number of cases pending before the Commission, the matter is taken up ex-parte based on record.

On perusal of the records, it appears that RTI Application was filed by the petitioner on 06.01.2014 seeking information relating to 12<sup>th</sup> Finance Commission, 13<sup>th</sup> Finance Commission and 14<sup>th</sup> Finance Commission for the year 2009-10 till 2013-14. He had also filed an Appeal petition before the Project Director, DRDA, Karimganj on 27.02.2014 and due to non-furnishing of information, filed a Complaint Petition dated 06.06.2014 before the Commission and thereafter there was no communication from the petitioner.

On perusal of the RTI Application, it appears that the information sought for by the petitioner is voluminous in nature. The Commission, therefore, directs the petitioner to inspect the relevant records and documents in the office of the Block Development Officer, Bodarpur Dev. Block, Bodarpur, Karimganj within 15 days from the date of receipt of this order if he is interested to receive the information.

The Block Development Officer, Bodarpur Dev. Block, Bodarpur, Karimganj is also directed to allow the petitioner to inspect the relevant record and documents as above and allow him to take notes and photocopies of the documents sought for, free of cost, upto 20 copies and thereafter on payment of Rs. 2/- for every additional page of photocopy.

With the above directions, the Complaint Petition dated 06.06.2014 is disposed of.
