The Petitioner Shri Tutiur Rahman Patikar is absent without any intimation.

The Public Authority is represented by Shri Ratan Deb, Manager, Assam Gramin Vikash Bank, H.O.-Bhangagarh. In view of the large number of cases pending before the Commission, the matter is taken up for hearing ex-parte.

On perusal of records it appears that an RTI Petition was filed on 18.12.2014 before the Branch Manager, AGV Kaliganj Branch and vide letter dated 21.02.2015 that the Petitioner was informed to take up the matter with appropriate authority as the matter doesn't relate to the office of AGVB, Kaliganj. The Petitioner thereafter filed a Petition dated 09.03.2015 before the Regional Manager, Assam Gramin Vikash Bank, Silchar and vide letter dated 30.03.2015, the Petitioner was informed that the information sought for was related to third party and have no relationship with any public activity or interest, disclosure of the same is exempted under section 8(1) (d), (e) and (j) of the RTI Act, 2005 and that the bank is under obligation to maintain secrecy about the affairs of its clients as per Section 13(1) of the Banking Companies Act, 1970.

The Petitioner, thereafter filed Second Appeal Petition dated 20.04.2015 before the Commission that he was not satisfied with the explanation given by the First Appellate Authority which was misleading and unjustified.

Since, the Petitioner is absent without any intimation, no hearing could be taken. The Commission observes that the Petitioner is no longer interested in receiving the information. As such the Second Appeal Petition dated 20.04.2015 is disposed of.
