**O R D E R**

The Petitioner Shri Indra Rongphar is absent, but has submitted a Written Statement dated 18.10.2016 that he has not received any reply from the SPIO, office of the Executive Engineer, Karbi Anglong Irrigation Division, Diphu against his RTI Petition dated 12.08.2015 and that the RTI First Appeal dated 29.09.2015 has not been heard by the First Appellate Authority. He has also stated that he doesn't require any document, but concerned official of the Karbi Anglong Division(Irrigation), Diphu may show the worksite/location of the scheme implemented.

The Executive Engineer, Karbi Anglong Irrigation Division, Diphu has submitted a Written Statement dated 14.10.2016 that he cannot authorize a person (Technical Officer) to accompany with the Petitioner for inspection of works without prior approval of KAAC Authority.

The Commission observes that the Schemes are implemented under the administrative control of Executive Engineer, Karbi Anglong Irrigation Division, Diphu. As such the Executive Engineer, Karbi Anglong Irrigation Division, Diphu is directed to observe formalities required and show worksites/locations of the Scheme u/s 2(j) of the RTI Act, 2005 within 21 days from the date of receipt of this order.

With the above directions, the Second Appeal dated 05.12.2015 is disposed of.
