**O R D E R**

The Petitioner Shri Indra Rongphar is absent, but has submitted a Written Statement that the SPIO had furnished Fund Release Orders not the name of Schemes under the award of 13<sup>th</sup> Finance Commission as mentioned in his RTI Petition dated 19.09.2015.

The Public Authority, Joint Secretary to the Govt. of Assam & SPIO, Elementary Education Department, Assam vide letter dated 19.10.2016 has submitted a Written Statement that information had already been furnished to the Petitioner vide letter dated 22.07.2016 and that RTI Petition dated 19.09.2015 submitted by the Petitioner had already been heard against the Case No. SIC/KAN.81/2016 and disposed of by vide Order dated 08.09.2016.

On perusal of the Case No. SIC/KAN.81/2016, the Commission observes that the Petitioner had filed several RTI Petitions on the same subject on the same date and 3 cases have been registered i.e. SIC/KAN.81/2016, SIC/KAN.195/2016 and SIC/KAN.196/2016 thereby causing undue harassment to the Public Authority concerned.

Since, same RTI Petition dated 19.09.2015 had already been dismissed on 08.09.2016 as the Petitioner was absent without any information on 3(three) consecutive dates. The Order passed in the case No. SIC/KAN.81/2016 stands and Case No. SIC/KAN.195/2016 and Case No. SIC/KAN.196/2016 are dismissed. He is once again directed to withdraw the multiple and superfluous petitions to save the concerned Public Authority and Appellate Authority from doing redundant and unnecessary works.
