The petitioner Shri Jawaharlal Narzary is present.

The Public Authority to be represented by the SPIO, office of the Addl. Principal Chief Conservator of Forests, KAAC, Diphu is absent without any intimation. In view of the large number of cases pending before the Commission, the matter is taken up for hearing ex-parte based on records.

On perusal of the records, it appears that the petitioner had sought for information from the Asstt. PIO, office of the Addl. Principal Chief Conservator of Forests, KAAC, Diphu vide letter dated 21.12.2015 seeking for information regarding the CA MPA Scheme/Works executed by the DFO, Karbi Anglong East Division/K.A. West Division/Dhansiri Division and Hamren Division for the period of 2010 till date of filing of the RTI petition.

The information sought for related to the office of the SDO of four divisions. It also appears that the First Appeal filed by the petitioner before the PIO, office of the Addl. Principal Chief Conservator of Forests.

During the hearing, the petitioner informed the Commission that he had filed 4(four) separate Appeals before the Commission relating to the 4(four) divisions which were duly processed in separate files. In this regard, he also presented a copy of the order dated 08.09.2016 of the Commission passed in the Case No. 132/2016.

On perusal of the order dated 08.09.2016, it appears that the subject matter of this appeal is same as that of Case No. 132/2016. Since, the matter has already been disposed of vide order dated 08.09.2016, this Second Appeal dated 27.05.2016 is dismissed.
