The petitioner Shri Chinmoyee Gogoi is absent without any intimation.

The Public Authority is represented by Shri Bimal Ch. Medhi, SPIO, SEBA, Guwahati and Shri Ajit Kr. Patwary, ASPIO, SEBA, Guwahati. He has submitted a Written Statement dated 05.10.2016 that the RTI petition dated 07.09.2015 seeking for photocopies of Answer Scripts of the subjects General Mathematics, General Science and Social Science of the HSLC examination, 2015 was received by the office of the SEBA on 22.01.2016, but last date of submission of RTI Application and necessary fees for photocopy of Answer Scripts was over on 02.10.2015. He has also stated that as per decision of the Board, all Evaluated Answer Scripts were disposed of after expiry of 4(four) months from the date of declaration of the HSLC Examination, 2015. A copy of order dated 19.11.2015 disposing the Scripts as per Board Rule has been enclosed. He has also stated that the petitioner was informed vide letter dated 05.03.2016 that photocopies of Answer Scripts could not be provided.

The Secretary cum First Appellate Authority, Board of Secondary Education, Assam has submitted a Written Statement stating the similar status as stated by SPIO, SEBA that since Evaluated Answer Scripts were disposed of on 02.10.2015, hence question of disposing of First Appeal dated 22.02.2016 does not arise.

In view of the circumstances stated above and absence of the petitioner for hearing today, the Second Appeal dated 18.03.2016 and Reminder dated 22.08.2016 are dismissed.
