O R D E R

The Complainant Shri Dhiraj Deka is present.

Written Statement from the SPIO, O/o the Director, Elementary Education, Assam and Deputy Director, Elementary Education, Assam (SIU), Directorate of Elementary Education, Assam received.

Perused the Written Statement. It has been submitted that the information sought for had provided through a letter dated 16.03.2016. Copies of the documents furnished to the Complainant have been enclosed for evidence.

Heard the Complainant. He submitted that he was still interested in the information and submitted a written request to treat his Complaint as an Appeal U/S 19 of the RTI Act, 2005. He further submitted that he was not satisfied with the information provided in respect of Point No. 3 of the Application dated 28.10.2015. He submitted that a copy of the advertisement for 61 posts has been provided to him instead of a copy the of Roaster Point- 100 in respect of those 61 posts.

The Commission by observes that the SPIO did not follow the proper procedure in transferring the RTI Application to a branch within the same Public Authority and that the procedure to be followed was to obtain the requested information from the concerned branch, namely- Apptt 'B' (SIU) and to forward it to the Applicant.

In view of the facts brought out above, the Commission hereby orders that the SPIO shall furnish the information sought for by the Appellant through Point No. 3 in his Application, namely- Apptt 'B' (SIU), the Roaster Point- 100 in detail in respect of the said 61 posts, free of cost, within 10 days of receipt of this order.

The Second Appeal case is hereby disposed of.
