Written Statement dated 25.10.2016 received from the District Social Welfare Officer, Karimganj and endorsement copy of the letter dated 29.09.2016 written by SPIO, office of the Director of Social Welfare addressed to the Appellant also received which are taken on record.

The Appellant present. He has submitted a copy of the letter dated 05.10.2016 which he had written to the SPIO, office of the Director of Social Welfare, Assam in connection with the information furnished to him.

From the perusal of the Written Statement and personal depositions, it is seen that some information has been furnished to the Appellant by the SPIO, Directorate of Social Welfare and not being satisfied with the information received, the Appellant had written to the said SPIO.

The main reason for the Appellant not being satisfied with the information was that he found it incomplete.

The SPIO, office of the Director of Social Welfare submitted that she had not received said letter from the Appellant. A copy of the said letter was handed over by the Appellant during the hearing.

In view of the facts brought out above, the Commission hereby orders that the SPIO shall review the representation made by the Appellant and specific response to the issues raised by the Appellant shall be given in writing within 10 days of receipt of this order.

The Second Appeal Case is hereby disposed of.
