Shri Ghana Kanta Das, Vice Principal and SPIO, P.B. College, Gauripur present alongwith Shri Samsuddoha Ahmed, Asstt. Professor. He has submitted a Written Statement dated 25.10.2016 which is taken on record.

The Appellant alongwith duly constituted Advocate, Shri Abdul Kuddus present.

Heard the Appellant. He has submitted that he has not received any information since his submission of Second Appeal dated 31.03.2016.

Heard the SPIO. He has submitted that he was not in a position to furnish the information on account of being pre-occupied with other urgent and important work of the College and time taken to gather the information. He was however ready to hand over the information/documents to the Appellant immediately.

Accordingly, the information/relevant documents were duly handed over to the Appellant in the course of the hearing. After perusal of the information /documents so received, the Appellant submitted that the information provided to him with regard to Point No. 3 of the Application was not fully in accordance with the information he had sought as the same did not specify detailed heads of account in which expenditure was booked.

The SPIO submitted that he should obtain the detailed information as required by the Appellant and would provide the same to him within 10 days of receipt of the Commission's order.

The Appellant having received the same and being satisfied, the Second Appeal case is hereby disposed of.
