<u>O R D E R</u> 27.10.2016

Smt. Mina Chakravorty, the Head Teacher of the 1106 No. Sanbani Nath Bidyapith M.E. School, Dhubri is present. She has submitted a Written Statement dated 27.10.2016.

The Appellant Md. Saman Ali SK is present.

Heard the Appellant. He submitted that he had not received the information he sought for.

Perused the Written Statement. It has been submitted that all the information sought for was not relevant or appropriate for her school and this was intimated to Block Elementary Education Officer, Bilasipara, Dhubri. Subsequently, the Appellant was requested to inspect the documents and late photocopies of the documents from the school. However, the Appellant did not respond. Further, she had gathered the information and the documents as available in the school office for the purpose of handing over the same to the Appellant excepting information sought at Point no. 5.

The Appellant stated that he had not received any communication from the Head Teacher of the said school.

Considering that the Head Teacher was ready with the information/documents excepting for information of Point no. 5. The Appellant was willing to receive the same at the end of the hearing and did not insist on Point no. 5.

He, however, submitted that he be allowed to make a representation in case the information provided to be to him was not complete.

The Commission hereby disposes of the Second Appeal with the observation that while making further representation on the information to be handed over to him today, the Appellant will keep in mind the fact that his RTI Application sought all kinds of information about the school for a period of seven years dating back to 2008 and that furnishing of the information and copies of documents has made a significant demand on the resources of the Lower Primary school. In other words, the Appellant is advised to use discretion in making further representation on the matter.
