Sarmah, Assistant Executive engineer (TC) & SPIO of the office of the Addl. Chief Engineer, PHE, KAAC, Diphu. The second appeal petition dated 18.5.16 is taken up for hearing in presence of both the parties. The SPIO of the office of the Addl. Chief Engineer, PHE, KAAC has submitted a written statement dated 28.9.16, which is entered into the case records.
