ORDER

The complainant Miss Nitashree Mili is absent without any information. The public authority is represented by Shri Padmalochan Nath, Associate Professor, DCB Girls' College, Jorhat accompanied by Shri Nabajit Hazarika, Jr. Asstt. of the DCB Girls' College, Jorhat. The complaint petition dated 4.3.15 is taken up for consideration ex parte in absence of the complainant.

From perusal of the case records it is seen that the petitioner filed an RTI petition dated 18.12.14 before the Principal of DCB Girls' College, Jorhat seeking information relating to her application and interview held on 16.12.14 for the post of Assistant Professor, Department of Geography, DCB Girls' College, Jorhat. The Principal of the College Dr. Jinamoni Bhuyan has sent a written submission dated 28.9.16 stating that on receipt of the petitioner's RTI petition dated 18.12.14, the petitioner was asked to deposit Rs. 500.00 being the cost for collecting information, which was already kept ready. The petitioner also deposited the cost on the same day and the College authorities provided the information to her with all relevant documents on 19.1.15 itself. The Principal has also stated in her WS that the complainant has since got appointment in the Cotton College, Guwahati and is working as such. In absence of the complainant she could not be heard. The main ground of the complaint is non-receipt of the information sought for by her within the stipulated period of 30 days. However, in view of the position stated in the written statement of the principal of the college and absence of the complainant at the time of hearing today, no further action could be taken by this Commission and hence the complaint petition dated 4.3.15 is disposed of.
