ORDER 30.9.2016

The concerned public authority that is Secretary of 63 No. Topatoli Gaon Panchayat is absent. The petitioner is represented by his Advocate, Ms. Dipika Das. The second appeal petition dated 10.6.15 is taken up for consideration ex parte in absence of the public authority.

It is seen that another RTI appeal case No. 578/2013 filed by the appellant Smti. Karabi Goswami was heard and disposed of on 16.11.2015, where also the subject matter was a plot of land under the Demoria Mouza, where the Topatoli GP office is located.

The Secretary of 63 No. Topatoli GP has sent a written submission dated 23.9.16 enclosing a certificate dated 12.10.2001 issued by the Circle Officer of Sonapur Revenue Circle stating that a plot of land measuring 5 bighas was allotted to 63 No. Topatoli Gaon Panchayat.

By filing multiple RTI petitions seeking informations about the plot of land allotted to the 63 No. Topatoli GP, the petitioner seems to have confused the issue. This second appeal petition dated 10.6.15 is therefore, disposed of with a direction to the Secretary, 63 No. Topatoli GP to furnish a copy of the certificate dated 12.10.2001 issued by the Circle Officer of Sonapur Revenue Circle within 15 days from the date of receipt of this order. If the petitioner needs any further information thereafter, he may file separate RTI petition specifying the information he requires and taking care that it is not repetitive and duplicitous with the informations already furnished to him.
