**O R D E R**

The petitioner Md/ Azizur Rahman is present. The public authority is represented by Sri Monoranjan Kalita, AGM of APDCL, Rangia Electrical Division.

The second appeal petition dated 16-8-2016 is taken up for hearing in presence of both the parties.

From perusal of the case records, it is seen that the petitioner filed an RTI petition dated 17-6-2016 before the AGM, Rangia Electrical Division of APDCL. This was followed by First Appeal Petition dated 26-7-2016. On 9-8-2016 the concerned AGM replied to the petitioner that the required information was not available in his office. This led to the second appeal petition dated 16-8-2016. However, the AGM, Rangia Electrical Division of APDCL has submitted a written statement dated 21-9-2016 before this Commission today. He has stated in his written statement that necessary information has meanwhile been furnished to the petitioner. He deposed that there are 3 Sub-Divisions under his jurisdiction that are involved with the RTI petition. Out of the 3 Sub-Divisions Rangia Electrical Sub-Division-I and Rangia Electrical Sub-Division-II furnished the information to the petitioner on 16-9-2016 and the Baihata Chariali Electrical Sub-Division furnished the information to the petitioner vide their letter dated 17-9-2016 . Copies of letters furnishing the information have been enclosed with the written statement. The petitioner, however, submitted that he has not received the information from Baihata Chariali Electrical Sub-Division. The AGM furnished a copy of the same to the petitioner in presence of this Commission today.

The AGM has furnished a copy of his letter dated 20-8-2016 furnishing point-wise information to the petitioner. The petitioner also submitted that he is satisfied with the information furnished to him except that all the 3 electrical Sub-Divisions mentioned above did not mention where they used the retrived electrical posts and transformers.

This Commission, therefore, directs the AGM , Rangia Electrical Division of APDCL to collect the above information from the 3 Sub-Divisions and furnish the same to the petitioner within 30 days from the date of receipt of this order , for which the petitioner will personally contact the AGM, Sri Monoranjan Kalita.

With the above order the second appeal petition dated 16-8-2016 is disposed of.
