The Appellant is absent but he has however, sent a Written Statement dated 29.09.2016.

The SPIO, Sanjib Kr. Phukan, Asstt. Academic Officer, O/o the Director, Madrassa Education, Assam and Syeda Moliha Sultana, Jr. Asstt., O/o the Director of Madrassa Education, Assam, Kahilipara are present and have submitted a Written Statement dated 03.10.2016.

Perused the Appellant's as well as the SPIO's Written Statement and heard the SPIO. It is seen that the Appellant has been provided with the information sought for by him based on records available that the SPIO/ Director of Madrassa Education, Government of Assam, and that the Appellant has acknowledged receipt thereof.

The point made by the Appellant in his RTI Application was that some information provided to him was wrong and contradictory, and some part of the information was not provided as being outside the purview of the Act. The SPIO submitted that some parts of the RTI Application were in the form of a questionnaire and therefore it was not possible to provide the information.

Perusal of the RTI Application indicates that it was in the form of long narrative and involved parts which suffered from lack of clarity and there were indeed questions that could not be related to any document containing information.

In view of the facts brought out above, the Commission hereby concludes that in view of the action already taken by the SPIO, it would suffice if SPIO respond para-wise to the Written Statement dated 29.09.2016 submitted by the Appellant to the Commission for today's hearing. The response may be sent to the Appellant within 21 days of receipt of this order.

The Complaint case is hereby disposed of.
