O R D E R 17.11.2016

Shri Jintu Phukan, CDPO, Juria ICDS Project, Nagaon as the SPIO is present.

The Appellant, Shri Durgeswar Das is present.

Heard the Appellant. He submitted that he had received the request for depositing an amount of Rs. 56,520/- (Rupees fifty six thousand five hundred and twenty) as an approximate cost of photocopy of the documents related to the information sought for. He did not deposit the said amount for the reason that he had received it after expiry of the stipulated 30 days for providing information and for want of detailed calculation.

Heard the SPIO. He submitted that the cost sought for from the Appellant was an estimate and that the breakup had been kept in the office and not enclosed with communication made to the Appellant. He also submitted that the documents to be photocopied were voluminous being related 30 Anganbari centres.

Considering that the information sought for related to all the Anganbari centres in the project as well as the CDPO and for the period from 2010-11. It is apparent that the number of documents to be photocopied and furnished would be substantial. It was agreed by the Appellant and the SPIO that the latter (the SPIO) shall offer for inspection the related records in the office and that the Appellant shall indicate the specific documents whose photocopies would be essentially required.

In view of the facts brought out above, the SPIO shall provide the information available in his office, free of cost, to the Appellant within 7 days of receipt of this order and intimate mutually convenient dates for inspection of record where upon the Appellant shall inspect the record, take notes and request for photocopy of the specific documents/pages of documents recorded by him. The SPIO shall provide upto 50 copies of such specified documents free of cost and the cost for photocopying beyond these numbers shall be borne by the Appellant. The notes/extracts made by the Appellant shall be certified by the SPIO or the custodian of the record.

The Second Appeal is hereby disposed of.
