O R D E R

Md. Habej Ali, Sr. Gram Sevak, Juria Dev. Block, Nagaon as the SPIO is present.

The Appellant, Shri Durgeswar Das is present.

Written Statement dated 15.11.2016 received from the SPIO.

Perused the Written Statement. It has been submitted that the RTI Application had been received by him only from the Commission with its hearing notice. The information on points 7-9 could not be provided for the reason that Juria Dev. Block has only distributed payment to the beneficiaries whereas the selection of the beneficiaries under CMSS was done by Rupohi and Moirabari Dev. Blocks. He had informed the Appellant about this by endorsing his letter dated 02.11.2016 written to the SPIO's Rupohi Dev. Block and Moirabari Dev. Block. He added that the letter was sent by registered post.

Heard the Appellant. He submitted that he had not received the aforementioned communication from Rupohi Dev. Block and Moirabari Dev. Block.

On the SPIO having offered copies of the documents containing the part of information relating to him, the Appellant did not receive the same as the documents were not accompanied by any explanatory forwarding letter and not certified.

In view of the facts brought out above, the Commission hereby orders as follows-

- (i) The SPIO shall furnish information/documents pertaining to him, free of cost, to the Appellant within 7 days of receipt of this order.
- (ii) The respective SPIO's of Rupohi Dev. Block and Moirabari Dev. Block shall furnish the information pertaining to them namely point number 7, 8 and 9 of the RTI Application dated 27.01.2016, forwarded to them by the SPIO, O/o the BDO, Juria Dev. Block, Nagaon, within 21 days of receipt of this order, free of cost.

The Second Appeal case is hereby disposed of.
