The SPIO absent but has submitted a Written Statement dated 19.11.2016 and also received a Written Statement dated 19.11.2016 from the First Appellate Authority/Sub-Divisional Officer (C), Bokakhat, Golaghat, Assam.

The Complainant, Shri Bijoy Kutum is present.

Heard the Complainant. He has submitted that he had received incomplete information and that he was still interested in the remaining information. He submitted a written request to convert his Complaint to Second Appeal.

Perused the Written Statements. In identical letters, the FAA/Sub-Divisional Officer (C), Bokakhat, Golaghat and the SPIO has provided information related to the action taken to provide information and dispose of the First Appeal with the order dated 23.12.2015, with the order to provide the remaining information in 7 days' time.

It has been added that the copies of the letters which were written to the Appellant has been enclosed.

The Appellant submitted that although he had received the aforementioned letters/information, the information was incomplete in respect of all the points in his RTI Application dated 30.10.2015.

In view of the facts brought out above, the Commission hereby orders that the SPIO shall thoroughly review the information provided to the Appellant, shall obtain full information in respect of all the points in the RTI Application and provide the same, free of cost, to the Appellant within 21 days of receipt of this order. Should any part of the information not be available in the office record, the position may be clearly explained to the Appellant in writing.

The Second Appeal is hereby disposed of.
