Shri Dibyajyoti Saikia, the PIO and Extension Officer (P), Pakhimoria Dev. Block, Nagaon and Shri Abu Nasser Md. Idrish, Extension Officer (Credit) are present.

The Appellant, Shri Durgeswar Das is present.

The First Appellate Authority/CEO, Zila Parishad, Nagaon has sent a Written Statement dated 09.11.2016.

Perused the Written Statement. It has been submitted that the information as received from the SPIO at the time of the hearing of the First Appeal has been furnished to the Appellant. The Written Statement bears signature of the Appellant presumably as a token of acknowledgement of receipt.

Heard the Appellant. He submitted that he had received the information/documents barring information in respect of Points No. 9-12 of his RTI Application dated 28.12.2015 and, that he was still interested therein.

The Commission observes that the SPIO has not provided the detailed information sought for from him by the Commission through its Hearing Notice dated 01.10.2016. Firstly, he has not indicated the date on which the RTI Application was received and why the information was not furnished within the stipulated time of 30 days. He has also not explained as to why penalty U/S 20 (1) of the RTI Act, 2005 shall not be imposed on him for his failure to furnish the information sought for within the stipulated time period.

In view of the facts brought out above, the Commission hereby orders that the SPIO shall furnish the remaining information, namely, that pertaining to Points No. 9-12 of the RTI Application to the Appellant, free of cost, within 15 days of receipt of this order.

The SPIO, O/o the BDO, Pakhimoria Dev. Block, is advised to be more diligent and prompt in furnishing information sought under the RTI Act, 2005 within the time frame prescribed therein.

The Second Appeal case is hereby disposed of.
