The Petitioner Sri Rohit Gupta is present.

The Public Authority to be represented by the Dist. Agricultural Officer, KAAC, Diphu is absent without any information.

On perusal of the RTI Petition, it appears that the information sought for by the Petitioner vide his RTI Petition dated 08.07.2016 is voluminous in nature relating to several categories of information for several years. Furnishing of complete information by making photocopies will require compilation of information and substantial cost in making photocopy.

The Commission, therefore, directs the petitioner to inspect the relevant records and documents in the office of the Dist. Agricultural Officer, KAAC, Diphu within 21 days from the date of receipt of this order and complete inspection of documents during office hours within two working day.

The District Agricultural Officer, Karbi Anglong Autonomous Council, Diphu, Karbi Anglong is also directed to allow the Petitioner to inspect the relevant record and documents as above and allow him to take notes and photocopies of the documents sought for, free of cost, upto 50 copies and thereafter on payment of Rs. 2/- for every additional page of photocopy.

With the above direction, the Second Appeal Petition dated 13.10.2016 is disposed of.
