The petitioner Md. Foriz Uddin Laskar is present.

The Public Authority to be represented by the SPIO, office of the Deputy Commissioner (Planning Cell), Hailakandi is absent without any intimation. The matter is taken up for hearing *ex parte* based on record.

On perusal of the record, it appears that the Petitioner had filed the RTI Petition before the Deputy Commissioner, Hailakandi on 01.02.2016 which was transferred to the SPIO/ADC, Planning Cell, office of the Deputy Commissioner, Hailakandi.

The Petitioner filed his First Appeal Petition before the Deputy Commissioner, Hailakandi on 04.05.2016 as he did not receive the information on his RTI Petition filed.

The Commission observes that the First Appeal Petition filed by the Petitioner was not disposed of by the First Appellate Authority/Deputy Commissioner, Hailakandi.

The Commission, therefore, remands the same to the Deputy Commissioner, Hailakandi for hearing and disposal of the same by speaking order within 21 days from the date of receipt of this order.

With the above direction, the Second Appeal Petition dated 03.11.2016 is disposed of.
