<u>O R D E R</u>

30.11.2016

The petitioner Md. Foriz Uddin Laskar is present.

The Public Authority to be represented by the Block Development Officers, Hailakandi/Lala/Algapur/Katlicherra/South Hailakandi Development Block, Hailikandi are absent without any intimation.

The First Appellate Authority/Project Director, DRDA, Hailakandi has submitted a Written Statement dated 21.11.2016 that the First Appeal Petition was received by the office on 10.05.2016 and all Block Development Officers were informed to appear in the hearing fixed before him on 06.06.2016. Due to unavoidable circumstances, hearing could not take place on the said date and next date for hearing was re-fixed on 21.07.2016 and vide his order dated 21.07.2016, the First Appellate Authority directed the Block Development Officers, Hailakandi/Lala/Algapur/Katlicherra/South Hailakandi Development Block to furnish the information sought for to the Applicant within 15 days i.e. 06.08.2016 without fail as they were absent during the hearing on 21.07.2016.

In the absence of the SPIOs, all Blocks noted above and Written Statement from them, the Commission is not in a position to verify the compliance or otherwise by the SPIO with the provision of the RTI Act, 2005. It is fact that the information sought for by the RTI Petition dated 03.03.2016 has not been furnished to the Applicant and that even after order of the First Appellate Authority dated 21.07.2016 to furnish the information within 06.08.2016 has not been furnished.

In view of the above position, the Commission hereby orders that the SPIOs, office of the Block Development Officer, Hailakandi/Lala/Katlicherra/South Hailakandi Development Block shall furnish the information sought for by the Petitioner within a period of 21 days from the date of receipt of this, if not already furnished.

The Commission also orders that the SPIOs shall submit written explanation to the Commission within 21 days from the date of receipt of this order as to why penalty shall not be imposed on him/her u/s 20(1) of the RTI Act, 2005 for failure to furnish the information sought for to the Applicant within stipulated period of 30 days.
