The Public Authority is represented by SPIO, Govt. of Assam, Revenue & D.M. Department, Dispur. The SPIO submitted a Written Statement dtd.22.11.2016 that the First Appeal Petition submitted by the Petitioner during 2015-16 was not received.

On perusal of the record, it is seen that the Commission had remanded the First Appeal Petition dtd. 28.01.2015 to the Commissioner and Secretary, Govt. of Assam, Revenue & DM Department, Dispur for disposal with a speaking order after hearing the Petitioner within 30 days from the date of receipt of this order. It appears that copy of the order of the Commission dated 03.06.2016 was marked by the Registry to the First Appellate Authority, Commissioner and Secretary to the Govt. of Assam, Dispur. The Department, Assam Revenue & DM Department was not mentioned in the copy issued to the First Appellate Authority which is a serious lapse on the part of the Registry of the Commission and is directed to be careful in future.

A copy of the order dated 03.06.2016 alongwith the RTI Petition dated 03.02.2009 and First Appeal Petition dated 28.01.2015 be issued to the Commissioner and Secretary to the Govt. of Assam, Revenue & DM Department, Dispur, Guwahati for disposal within 21 days from the date of receipt of this order.

With the above direction, the Second Appeal Petition dated 21.04.2015 is disposed of.
