**O R D E R**

The Petitioner Sri Indra Rongphar is absent, but has informed the Commission vide letter dated 23.11.2016 that he has not received the information sought for from the office of the Addl. Chief Engineer, Irrigation (Zone-IV), Diphu, Karbi Anglong against his RTI Petition dated 20.10.2014.

The Public Authority is absent without any intimation. In view of large number of cases pending before the Commission, the matter is taken up for hearing based on record.

On perusal of the RTI Petition, it appears that the information sought for by the Petitioner vide his RTI Petition dated 20.10.2014 is voluminous in nature relating to several categories of information for several years. Furnishing of complete information by making photocopies will involve substantial cost.

The Commission, therefore, directs the Petitioner to inspect the records/documents in the office of the Addl. Chief Engineer, Irrigation, Zone-IV, Diphu, Karbi Anglong within 21 days from the date of receipt of this order and complete the inspection of documents/records during office hours within two working days.

The Addl. Chief Engineer, Irrigation, Zone-IV, Diphu, Karbi Anglong is also directed to allow the Petitioner to inspect the relevant documents/records as above and also allow him to take notes and photocopies of the sought for documents, free of cost, upto 50 copies and thereafter on payment of Rs. 2/- for every additional page of photocopy.

With the above direction, the Second Appeal dated 17.02.2015 is disposed of.
