O R D E R 18.11.2016

The Petitioner Sri Indra Rongphar has submitted a Written Statement dated 18.11.2016 that he has not received the information sought for from the SPIO, office of the Block Development Officer, Howraghat Development Block, Howraghat, Karbi Anglong against his RTI Petition dated 08.04.2015.

The Public Authority is represented by Sri Dhiraj Saikia, Asstt. Statistical Officer, DRDA, Karbi Anglong. The Project Director, DRDA Karbi Anglong/First Appellate Authority has submitted a Written Statement dated 10.11.2016 that the First Appeal Petition was received by the office on 08.06.2015 and date for hearing to dispose the matter was fixed on 14.08.2015 at 11.00 am. Due to Karbi Anglong Bandh called by some Organization, the hearing could not be held on 14.08.2015 and again hearing was re-fixed on 29.10.2015. He also stated that he was not aware whether the hearing had taken place as no record in this regard could be traced.

The Commission observes that the First Appeal Petition filed by the Petitioner dated 03.06.2015 was not disposed of by the First Appellate Authority and directs the First Appellate Authority to hear the Petitioner on a date fixed and dispose of the Petition by Speaking Order within a period of 10 days from the date of receipt of this order.

With the above direction, the Complaint Petition dated 28.09.2016 is disposed of.
