**O R D E R**

The petitioner Sri Uday Kalita is present. The public authority is represented by:-  
(1) Sri Binod Bhattacharyya. Extension Officer (Fishery), Boitamari Development Block, Boitamari.

It is seen that the public authority as well as the petitioner/appellant in appeal case No. SIC/BNG/55/2016 are the same. The information sought for in both the cases are also identical against 4 different schemes viz- 4<sup>th</sup> State Finance Commission, 12<sup>th</sup> Finance Commission, DDP and 13<sup>th</sup> Finance Commission against case No. SIC.53/2016 and 4 other schemes viz.- BRGP, NREGA, IAY and MSDP, against appeal case No. SIC/BNG/55/2016. All the schemes relate to Boitamari Anchalik Panchayat and for the same Financial Years 2006-2007 to 2012-2013 - for which information is sought for which are is also the same. It is, therefore, decided with the consent of both the parties to club both the cases together and hear it as one case in presence of both the parties.

The First Appellate Authority and BDO, Boitamari Development Block has filed a written submission dated 17-11-2016 which is entered into the case records.

From perusal of the information sought for against the eight schemes for the period 2006-2007 to 2012-2013 in respect of Boitamari Anchalik Panchayat, it appears that the information will be voluminous and it is likely to disproportionately divert the resources of the public authority.

This Commission , therefore, directs Sri Binod Bhattacharyya, Extension Officer, (Fishery) and SPIO of Boitamari Development Block, to allow the petitioner/appellant to inspect all relevant records and documents in respect of the seven RTI petitions, during office hours on any working day, within 15 days from the date of receipt of this order and allow the petitioner to take notes and photo copies of relevant documents required by him, free of cost up to 100 pages of photo copies and thereafter on payment of Rs. 2.- for every page of additional pages of photo copies.

In case, any of the information sought for is not available or cannot be furnished by the PIO, he will give reasons thereof in writing to the petitioner

With the above order, both the second appeal petitions dated 5-4-2014 is disposed of.
