ORDER

The petitioner Sri Bikash Das is present. The public authority is represented by :- (1) Dr.Hiranya Kr. Sarma, Principal, Suren Das College, Hajo, (2) Sri Biswajit Klalita, PIO of the same college, and (3) Dr. Arup Kr. Deka, APIO of the same college.

The second appeal petition dated 1-7-2016 is taken up for hearing in presence of both the parties.

From perusal of the case records it is seen that the petitioner filed an RTI petition dated 4-3-2016 seeking informations about the different aspects of the functioning and financial matters of Suren Das College, Hajo , Kamrup (Rural) district, Assam

The petitioner stated that he has in the meanwhile received from the college authorities some partial information with which he is not satisfied.

The Principal of the College Dr. H. K. Sarma has made a written submission dated 21-11-2016 narrating the actions taken by him so far on the petitioner's RTI application dated 4-3-2016.

This Commission is of the view that the information sought for are voluminous and general in nature. This Commission, therefore, directs the PIO of Suren Das College, Hajo to allow the petitioner to inspect the relevant records and documents, during office hours on any working day within 15 days from the date of receipt of this order and allow him to take notes and photo copies of documents sought for by him, free of cost up to 100 pages and thereafter against payment of Rs. 2/- for every additional page of photo copy.

With the above order the second appeal petition dated 1-7-2016 is disposed of.
