**O R D E R**

30.11.2016

The petitioner Md. Mohibul Hoque is absent without any information. The public authority is represented by Shri Ram Prasad Saikia, incharge APO (T) & SPIO, Goalpara Zilla Parishad. The second appeal petition dated 3.6.14 is taken up for hearing ex parte in the absence of the petitioner.

From perusal of the case records it is seen that the petitioner Md. Mohibul Hoque filed an RTI petition dated 3.2.14 before the SDO (C), North Salmara, Abhayapuri seeking information in the matter of deputation of one Shri Nirmal Nath, Asstt. Engineer, PHE Department to DRDA, Goalpara for posting as APO (T). The SPIO of the office of the SDO (C) transferred the RTI petition to the SPIO of the office of the CEO, Goalpara Zilla Parishad vide letter dated 5.2.14. Shri Ram Pr. Saikia, incharge, APO(T) and SPIO of Goalpara Zilla Parishad has submitted a written statement dated 25.11.16 enclosing a copy of letter dated 22.11.16 addressed to the petitioner Md. Mohibul Hoque by the APO & SPIO of Goalara DRDA furnishing point-wise replies to the petitioner in response to his RTI petition dated 3.2.14. Another appeal case No. SIC/BNG.54/2016 relating to the same subject involving RTI petition by the same petitioner was also heard today and a speaking order was already passed.

In view of the information already furnished by the SPIO of DRDA, Goalpara in this case read with this Commission's order in the other appeal case No. ISC/BNG.54/2016 and the absence of the appellant at the time of hearing of appeal case today, there does not seem to be any further cause of action for this Commission. Hence the second appeal petition dated 3.6.14 is disposed of.
