O R D E R

The petitioner Shri Utpal Das is absent without any information. The public authority is represented by:- Shri Golak Ch. Das, APS, Dy. S.P., Assam Police HQ, Ulubari, and (2) Shri Paresh Baruah, ASI of the AP HQ. The second appeal petition dated 22.9.16 is taken up for hearing ex parte in the absence of the petitioner.

The AIGP(A) and PIO of Assam Police Headquarters has submitted a written statement dated 1.12.2016, which is entered into the case records. In his WS he has stated that the information sought for by the petitioner related to several other public authorities which included all District superintendents of Police, SSPs, CID, SP, BIEO and DCP (A). The RTI petition was, therefore, transferred to all of them vide letter 18.6.16. The PIO has also mentioned in his WS that many of the concerned public authorities to whom the RTI petition was transferred have meanwhile furnished the sought for information directly to the petitioner, some of them with copies to the AIGP(A) and PIO, copies of which have also been enclosed with the WS.

In view of the above and in the absence of the appellant/petitioner, this Commission could not proceed any further with the second appeal petition dated 22.9.16 filed by the appellant Shri Utpal Das. If the petitioner is yet to get satisfactory response from any of the concerned public authorities to whom the RTI petition dated 18.16 was transferred by the AIGP (A) and PIO, he may then take up directly with those public authorities severally and they are directed to furnish the required information to the petitioner within 30 days from the date of receipt of communication/request from the petitioner, which he will make within 15 days from the date of receipt of this order.

With the above order, the second appeal petition dated 22.9.16 is disposed of.
