O R D E R

The public authority is represented by:- (1) Md. Saifuddin Ahmed, Superintendent & ASPIO of the office of the Commissioner of Transport, Govt. of Assam, (2) Shri Anjan Chakraborty, Jr. Assistant, and (3) Shri Guptajit Das, Jr. Assistant of the office of the Commissioner of Transport, Guwahati-22. The petitioner Shri Dulal Bora is absent without any information. Nor has he submitted any prayer for deferment of the hearing. Hence his second appeal petition dated 17.10.13 followed by further petition dated 31.8.15 are taken up for hearing ex-parte.

The ASPIO and superintendent of the office of the Commissioner of Transport has submitted a written statement dated 14.12.16, which is entered into the case records.

From perusal of the case records it is seen that the petitioner filed an RTI petition dated 6.7.13 before the SPIO of the office of the Commissioner of Transport, Govt. of Assam. It is also seen from the case records that the RTI petition was transferred to all the DTOs vide Transport Commissioner's office letter No. CST.E/31/2013 dated 9.7.13 as the informations sought for are held by concerned District Transport Officer. The SPIO and Deputy Commissioner of Transport informed the petitioner vide letter No. CT/RTI/290/2013 dated 7.12.13 about the actions already taken by the office of the Commissioner of Transport. The petitioner was also informed that some of the DTOs' offices had already furnished information directly to the petitioner. For the remaining informations, the petitioner was requested to contact the concerned DTOs. In his latest prayer dated 31.8.15 the petitioner has

only mentioned that he was not furnished with the required informations within the stipulated period of 30 days. There is no mention of whether he followed up with the defaulting DTOs and the outcome thereof. Further, the petitioner has not mentioned who are the defaulting DTOs against whom he wants action to be taken.

In view of the above and in the absence of the petitioner, this Commission could not proceed any further. Hence his petitions dated 17.10.13 and 31.8.15 are, therefore, disposed of. The petitioner will however, be at liberty to submit fresh RTI application on the same subject before the concerned DTOs.
