ORDER

16.12.2016

The petitioner Shri Dulal Bora is absent without any information. Nor has he prayed for deferment of the date of hearing. The public authority is represented by Dr.N. Rajamarthandan, Spl. Superintendent of Police, CID, Assam & SPIO accompanied by Shri Ranjit Deka, ASI of Police, CID. The second appeal petition dated 6.212.13 is taken up for hearing ex-parte in the absence of the petitioner. The SSP, CID present today submitted before this Commission a copy of their letter dated 3.11.16 addressed to the Registrar incharge of this Commission, which is already available in the records.

From perusal of the case records it is seen that the petitioner Shri Dulal Bora filed an RTI petition dated 3.6.13 before the Director General of Police, Assam seeking informations about a raid conducted by the CID organization in the Guwahati branch office of NBFC called Jeevan Suraksha in 2011. The petitioner was informed vide letter dated 5.6.13 and again by letter dated 2.9.13 that the sought for information could not be furnished as the Criminal Investigation Department (CID) is an organization exempted u/s 24 of the RTI Act. This Commission also observes that in his second appeal petition dated 6.12.13, the only ground adduced by the petitioner is non-receipt of the sought for informations. Section 24 of the RTI Act, 2005 read with Political (A) Department's notification no. LPA.384/2005/54 dated 8th March, 2006 shows that CID is an exempted organization under the RTI Act, 2005 and it is not required to furnish information to the information seeker unless the sought for information pertains to allegations of corruption or human rights violation. The second appeal petition mentions none of these two grounds. Hence this

Commission finds the second appeal petition dated 6.12.13 without merit, therefore, it is disposed of.
