**O R D E R**

The petitioner Sri Mohar Ali is present. The public authority is represented by :-  
(1) Sri Dinobondhu Das, Secretary, Pachania Kharagaon Gaon Panchayat.

The second appeal petition dated 13-2-2015 is taken up for hearing in presence of both the parties.

The petitioner made a written submission stating that after filing his second appeal petition dated 13-2-2015, he has received the remaining information from the Secretary of the Pachania Kharagaon G.P to his satisfaction.

In view of this there appears to be no further cause of action and hence the second appeal petition dated 13-2-2015 is disposed of.

While disposing of the second appeal petition this Commission observes that the information sought for by the petitioner related to list of IAY beneficiaries. **Such information is mandatorily required to be put up in public domain by the concerned public authority under Section 4(1)(b). Obviously the concerned BDO did not do so.**

This Commission, therefore, directs, in exercise of powers conferred under Section 19(8)(a), the **Commissioner of Panchayat and Rural Development to advise all administrative units under his jurisdiction to immediately comply with Section 4 of the RTI Act, 2005 with intimation to this Commission.**
