**O R D E R**

The petitioner Sri Niranjana Ray is present. The public authority is represented by Sri Abdul Karim, BDO, Tapattary Development Block.

The second appeal petition dated 24-4-2013 and subsequent non-compliance complaint petition dated 17-2-2016 are taken up for further hearing in pursuance of this Commission's earlier order dated 3-12-2015.

In course of hearing today, it transpired that in compliance with this Commission's order dated 3-12-2015 the petitioner went to the office of the BDO, Tapattary Development Block for inspection of documents. But he was unable to get any information from the BDO's office. This Commission takes a serious view of the non-compliance of this Commission's order. This Commission directs the BDO, Tapattary Development Block to allow the petitioner to inspect the relevant documents/ records and take photo copies of documents required by him, free of cost up to 50 copies and thereafter on payment of Rs. 2/- for every additional page of photo copy. The inspection of records and furnishing of photo copies thereof, as ordered above, shall be completed by 10<sup>th</sup> January, 2017, as agreed to by both the parties.

With the above order the second appeal petition dated 24-4-2013 and non-compliance complaint petition dated 17-2-2016 are disposed of.
