**O R D E R**  
22.12.2016

The SPIO, O/o the DC, Barpeta who was notified of today's hearing is absent. However, he has submitted a Written Statement dated 13.12.2016. On his advice, Dr. Manoj Kr. Mahanta, Principal, Bajali College, Pathsala, Shri Debaprasad Misra, Head of the Deptt., English, Bajali College and Shri Dipak Baruah, Bajali College, RTI Cell are present.

The Appellant, Shri Prasanta Kakati is present.

Heard the Appellant. He submitted that he has not received the information through his RTI Application dated 16.03.2016.

Perused the Written Statement. It has been submitted that the RTI Application was transferred to the Principal, Bajali College, Barpeta through a letter dated 30.03.2016 and that the SPIO, O/o the Principal, Bajali College, Barpeta had been requested to attend today's hearing.

Heard the Principal. He submitted that he had not received the said Application and therefore has not been able to furnish the information sought for.

A perusal of the record indicates that through the said RTI Application the Appellant had sought information relating to proceedings of GB meetings of a particular period and matters relating to land of the college.

On having perused the Application, the Principal submitted that he would be able to furnish the information as available in the record of the college.

In view of the facts brought out above, the Commission hereby orders that the SPIO, O/o the Principal, Bajali College shall provide specific information, free of cost, as sought for by the Appellant within 15 days from the date of receipt of this order.

The Second Appeal is hereby disposed of.
