## <u>O R D E R</u> 04.02.2017

The SPIO is absent. A Written Statement has been received from the Sub-Divisional Officer (Civil), Bajali, Pathsala dated 02.02.2017.

Perused the Written Statement. It has been submitted that in compliance with the Commission's order dated 05.08.2016, a copy of the document in question had been procured and furnished to the Appellant through letter no. BJLA -6/2012/II/934 dated 19.08.2016. It has further been submitted that in response to the Commission's letter dated 22.09.2016 whereby an Action Taken Report has been sought on the said order of the Commission, a report had been sent to the Commission dated 18.11.2016. Photocopies of the said letters dated 19.08.2016 and 18.11.2016 have been enclosed for evidence.

The Appellant, Shri Nabin Talukdar is present along with an assistant.

Heard the Appellant. He submitted that he had not received the said documents and the letter dated 19.08.2016.

The SPIO and the SDO (Civil), Bajali, Pathsala have not furnished any evidence of the Appellant having received the said letter dated 19.08.2016. A photocopy of the office copy of the said letter and that of what appears to be a peonbook or register do not bear any acknowledgement of receipt by the Appellant.

In view of the facts brought out above, the Commission is unable to determine as to whether the said letter with the requisite documents was indeed delivered to the addressee.

In view of the facts brought out above, the Commission hereby orders that the SPIO, O/o the SDO (Civil), Bajali, Pathsala shall send another copy of the said document, namely the letter regarding acquisition of land, to the Appellant, free of cost, within 10 days of receipt of this order by Registered Post.
