**O R D E R**

Dr. Jayanta Gogoi, Principal, J.D.S.G. College, Bokakhat, Golaghat and Shri Prasanta Saikia, PIO, O/o the J.D.S.G. College, Bokakhat present. They have submitted a Written Statement dated 04.01.2017.

The Appellant/Complainant is absent. He has however, sent a letter dated 03.02.2017 by e-mail.

Perused the Appellant's letter. It has been submitted that he was not satisfied and that the information furnished to him were incomplete. However, he has not specified the shortcomings in the information received to indicate to the point as to why he was not satisfied.

Perused the W/S submitted by the Principal of the College along with enclosure.

From the perusal and personal deposition of the Principal and SPIO of the College, in respect of the seven out of the eight points on which the Commission had issued an order dated 28.11.2016 for furnishing information to the Appellant was incomplete in respect of point no. 2 and 8. In respect of point no. 4, it has been submitted that copy of the concerned documents had been furnished to the Appellant and the letter did not specify as to whether he was not satisfied with it.

After a careful consideration of the submission dated 03.02.2017 made by the Appellant, the Commission is of the view that the Appellant has not represented his case of non-compliance by the SPIO clearly with specific reference to the points of the information he had sought for and therefore advises the Appellant to be more specific in submitting his Appeals under the RTI Act, 2005 in future.

Further, based on the case records and the submissions, the Commission hereby orders that the SPIO shall furnish specific information with reference to point nos. 2 and 8 of the RTI Application dated 14.03.2016, free of cost, within 10 days of receipt of this order.

A copy of the Appellant's Complaint dated 03.02.2017 has been handed over to the public authority for reference and response.

With this, the Second Appeal/Complaint case is hereby disposed of.
