**O R D E R**  
06.02.2017

The SPIO is absent. However, he has submitted a Written Statement dated 01.02.2017.

A W/S has been received from the First Appellate Authority/ Block Dev. Officer, Juria Dev. Block dated 30.01.2017.

The Appellant, Md. Abdul Barik is present.

Heard the Appellant. He submitted that he had not received the information he had sought for.

Perused the W/S of the SPIO. He has submitted that the information had been sent to the Appellant through a peon but the Appellant did not receive the same. It has also been submitted that the Appellant had requested several times by telephone to collect the information from the office but the latter did not respond. As the Appellant did not respond, to the information was finally sent by Ordinary Post.

The Appellant submitted that he had not received any communication from the SPIO.

It is seen that the SPIO has not given any evidence for claims he has made such as photocopy of the peon book and any report by the messenger. There is also no evidence of the letter containing the information having been posted.

Perused the W/S of the FAA. It has been submitted that the First Appeal was heard and an order issued dated 30.01.2017 directing the SPIO to furnish the information.

On the copy of the letter dated 23.05.2016 claimed to have been furnished by the SPIO shown to the Appellant been shown to him, the Appellant submitted that it did not contain the detailed information he had sought for and the response on the first point of his RTI Application did not mention all the schemes such as TFC scheme, PMGY etc.

In view of the facts brought out above, the Commission hereby orders that the SPIO, O/o the Secretary, Boralimari Furhaniati GP, Nagaon shall review the information claimed by him to be furnished to the Appellant with reference to the RTI Application dated 02.03.2016 and furnish a to-the point information to the Appellant, free of cost, within 10 days of receipt of this order by Registered Post.

In view of the facts brought out above, the Second Appeal is hereby disposed of.
