The petitioner Shri Dhani Ram Maslai is absent without any intimation.

The Inspector of School, Karbi Anglong District Circle, Diphu has submitted a Written Statement dtd. 17.01.2017 that he is not the implementing authority of Mid-Day Meal Scheme in the Schools (Secondary) of Karbi Anglong. The said Scheme is implemented by Sarba Siksha Abhijan (SSA), hence the matter may be closed.

As per section 6 (3) of the RTI Act, 2005 – “Where an application made to a public authority requesting for information is held by another public authority, the public authority to which such application is made, shall transfer the application to the appropriate authority and inform the applicant immediately about such transfer. As such transfer application shall be made as soon as practicable but no case later than five days from the date of receipt of the application.”

The Commission directs the Inspector of Schools, Karbi Anglong District Circle, Diphu to take appropriate action accordingly.
