**O R D E R**

20.01.2017

The petitioner Shri Abdul Hakim is present.

The Public Authority is represented by Sri Jahirul Islam, Headmaster, Dakhin Chakla Bilpara L.P. School, Goalpara and Sri Mohidul Islam, Junior Assistant authorized by the Block Elementary Education Officer, Lakhipur Block, Goalpara.

The Headmaster, Dakhin Chakla Bilpara L.P. School, Goalpara has submitted a Written Statement dtd. 18.01.2017 that the petitioner Shri Abdul Hakim has been submitting RTI petition on the same subject since 10.03.2011 and the District Elementary Education Officer, Goalpara vide letter dtd. 21.03.2011 directed him to submit all the particulars and accordingly he had submitted all the particulars at the office of the District Elementary Education Officer on 01.11.2011 and 18.11.2011 which has been received by the petitioner himself. He also stated that in addition to the RTI petition he had filed a case against the School to achieve personal gain and as per decision of the public meeting held on 13.03.2012, the petitioner agreed to withdraw the case on payment of Rs. 12000/- which was paid to him. It was also recorded in the minutes that in case of necessity of appointment of a cook, wife of Abdul Hakim would be appointed. He stated that the petitioner has been harassing him for his personal gain since 2011 till date. The petitioner was furnished the information again on 06.10.2015.

On perusal of the relevant papers, it is seen that the petitioner was present in the meeting held on 13.03.2012 and it was recorded in the minutes that Rs. 12,000/- was paid to the petitioner by Shri Jahirul Islam. It is also seen that the petitioner had himself received the documents sought for by him and in spite of the same, he had been seeking for the same information time and again. The petitioner should restrain from indulging in such unfair and illegal activities.

The second Appeal petition dtd. 01.08.2016 filed by Shri Abdul Hakim is dismissed.
