**O R D E R**  
20.01.2017

The petitioner Shri Rohit Gupta has informed that he is unable to attend the hearing today as he met with an accident on 19.01.2017 and that he had not received any information from the Public Authority. He also stated that he has received a letter No.E-1/RTI/2017/2960-61 dtd. 20.10.2017 on the subject of submission of RTI reply asked by Sri Rohit Gupta, but no enclosures were received by him.

The Public Authority to be represented by the Inspector of Schools, Karbi Anglong Dist. Circle, Karbi Anglong is absent. He has sent a letter dtd. 20.10.2017 referred to above, enclosing some documents to the Commission. It is seen that the date has been wrongly noted as 20.10.2017. Since, the letter has been received by the Commission on 19.01.2017, it is deemed to be dt. 19.01.2017. On perusal of the letter, it is seen that the information on points No. 3 to 5 on the RTI petition has been enclosed, but regarding point No. 1 & 2, it has been stated that records are not available.

The Commission directs the Inspector of Schools to intimate the petitioner why records are not available and what action had been taken for making the same available. He is also directed to furnish the documents sent to the Commission to the petitioner within 15 days from the date of receipt of this order.

With the above direction, the second Appeal petition dtd. 02.12.2016 is disposed of.
