**O R D E R**

The petitioner Md. Zarjish Ahmed Laskar is present.

The Public Authority to be represented by SPIO, office of the Children Development Project Officer, Hailakandi is absent without any intimation.

From perusal of the case record, it is seen that the petitioner filed an RTI petition dated 10.06.2016 before the PIO, office of the Children Development Project Officer, Hailakandi seeking for information relating to details of Anganwadi Centre at Hailakandi. He also filed first Appeal petition before the PIO, District Social Welfare Officer, Hailakandi on 22.07.2016. Due to non-receipt of the information, the petitioner filed second Appeal before the Commission for releasing of the information.

The Commission observes that the information sought for by the petitioner vide RTI petition dated 10.06.2016 involves a huge volumes of information relating to several categories of information for the year 2013 to 2016. Furnishing of complete information by making photocopies will involve huge expenditure of the concerned Public Authority.

The Commission, therefore, directs the petitioner to inspect the relevant office records and documents, with prior intimation to the office of the Children Development Project Officer, Hailakandi within 15 days from the date of receipt of this order and complete inspection of documents during office hours within two working days.

The PIO, office of the Children Development Project Officer, Hailakandi is directed to allow the petitioner to inspect the relevant documents as above and allow him to take notes and photocopies of sought for documents, free of cost, upto 50 copies and thereafter on payment of Rs. 2 /- for every additional page of photocopy.

With the above direction, the second Appeal petition dtd. 08.09.2016 is disposed of.
