The petitioner Shri Indra Rongphar has informed that he has not received any information sought for against his RTI petition dtd. 30.05.2016 till date and that he will not be able to attend the hearing fixed today due to illness.

The Public Authority to be represented by the Child Development Project Officer, Rongkhang ICDS Project, Donkamokam is absent without any intimation.

On perusal of records, it is seen that the petitioner Shri Indra Rongphar vide his RTI petition dtd. 30.05.2016 has sought for information regarding implementation of Rongkhang ICDS Project with details of operational AWCs under the project in village –wise, fund released by District Level Committee of SNP in Karbi Anglong District to the bank account of CDPO, Rongkhang ICDS Project during the year 2014-15 to 2016-17 for execution of activities of supplementary nutrition, details of expenditure incurred against implementation of activities of supplementary nutrition during the aforesaid financial years etc.

The Commission observes that the information sought for by the petitioner vide his RTI petition dtd. 30.05.2016 involves a huge volume of information relating to several category of information for several years. Furnishing of complete information by making photocopy will require compilation of information and substantial cost in making photocopies.

The Commission, therefore, directs the petitioner to inspect the relevant office record and documents in the office of the Child Development Project Officer, Rongkhang ICDS Project, Donkamokam, Karbi Anglong with prior intimation to the office of the Child Development Project Officer within 15 days from the date of receipt of this order and complete inspection of documents during office hours within two working days.

The Child Development Project Officer, Rongkhang ICDS Project, Donkamokam, Karbi Anglong is also directed to allow the petitioner to inspect the relevant documents as above and allow him to take notes and photocopies of sought for documents, free of cost, upto 50 copies and thereafter on payment of Rs. 2/- for every additional page of photocopy.

In view of the above, the Complaint petition dtd. 24.11.2016 which is an actual Appeal praying for information is disposed of.
