The petitioner Shri Rangina Tisso is absent without any intimation.

The Head Master, Binapani High School, Dharamnala Road, Diphu, Karbi Anglong has intimated that due to medical emergency, he will not be able to attend the hearing on 18.01.2017 and has requested to re-fix the hearing date after 15 days.

The District Mission Co-ordinator, SSA & Mid Day Meal Scheme, KAAC, Diphu has deputed Sri Rajkumar Chauhan, Dist. Accounts Officer, MDMS, SSA, KAAC to attend the hearing. He stated that information relating to points No. 1 & 2 is available in the office of the District Mission Co-ordinator w.e.f. 2014 and prior to that, records were maintained by the office of the District Council and the Deputy Commissioner, Hailakandi. He also stated that he would be able to furnish the information available with him within a week.

The Commission observes that the information sought for by the petitioner involves a huge volume of information relating to several category of information for several years. Furnishing of complete information by making photocopy will require compilation of information and substantial cost in making photocopies.

The Commission, therefore, directs the petitioner to inspect the relevant office record and documents in the office of the Head Master, Binapani High School within 21 days from the date of receipt of this order with prior intimation to the Head Master concerned and complete inspection of documents during office hours within two working days.

The Head Master, Binapani High School, Diphu is also directed to allow the petitioner to inspect the relevant documents as above and allow him to take notes and photocopies of sought for documents, free of cost, upto 50 copies and thereafter on payment of Rs. 2/- for every additional page of photocopy.

With the above direction, the second Appeal petition dtd. 03.12.2016 is disposed of.
