O R D E R 10.01.2017

The petitioner Shri Livingstone Bey has informed that he has not received any information till date from the concerned SPIO, office of the Executive Engineer, Karbi Anglong Division (Irrigation), Diphu, Karbi Anglong and he is unable to attend the hearing on 10.01.2016 due to financial problem.

The Public Authority is absent without any intimation.

On perusal of the records, it appears that the petitioner filed an RTI petition on 09.03.2016 seeking information against 50, 60 & 64 nos. of flow irrigation scheme under AIBP along with details for the period of 2012-13 to 2015-16. Due to non-receipt of information, he filed first Appeal petition dtd.29.04.2016 before the Executive Engineer, Karbi Anglong Division (Irrigation), Diphu and the Executive Engineer vide letter No. KADI/255/2012-13/412 dtd. 23.05.2016 had furnished the information to the petitioner. The petitioner filed 2<sup>nd</sup> Appeal petition before the Commission on 20.06.2016 on the ground that complete information was not received from the Public Authority.

The Commission, therefore, remands the matter to the first Appellate Authority for hearing and disposal of the same with a speaking order within 30 days from the date of receipt of this order.

With the above direction, the 2<sup>nd</sup> Appeal petition dtd. 20.06.2016 is disposed of.
