**O R D E R**  
**17-2-2017**

The petitioner Sri Vinod Mandal is present. The public authority to be represented by the SPIO of the office of DFO, Guwahati Wild Life Division, Santipur, Guwahati-9 is absent without any information.

The non-compliance complaint petition dated 4-2-2017 filed by the petitioner Sri Vinod Mandal complaining that the DFO, Guwahati Wild Live Division has not yet complied with this Commission's order dated 29-6-2016 whereby he was directed to furnish the informations sought for by the petitioner vide his RTI petition dated 20-5-2014 free of cost to the petitioner within 15 days from the date of receipt of the order. In the absence of the respondent or any written submission from his end, it could not be ascertained whether the DFO , Guwahati Wild Life Division have in the meanwhile taken any action to comply with this Commission's order dated 29-6-2017.

In view of the above, this Commission directs the DFO, Guwahati Wild Life Division to :-

- 1) **Comply with this Commission's earlier order dated 21-6-2017 on or before 10<sup>th</sup> March, 2017 by sending the sought for information to the petitioner by Registered A/D post.**
- 2) **Show cause within 10<sup>th</sup> March, 2017 as to why penal actions under Section 20 of the RTI Act, 2005 shall not be initiated against him for non-compliance of this Commission's order dated 29-6-2017.**

Fix **3<sup>rd</sup> April, 2017 at 12.00 A.M** for personal hearing of DFO, Guwahati Wild Life Division and review of the complaint petition.
