The second appeal petition dated 19-12-2016 filed by the petitioner is taken up for hearing in presence of both the parties.

From perusal of the case records, it is seen that the petitioner submitted an RTI petition dated 1-6-2016 before the SPIO of Agriculture Department, Govt. of Assam seeking various informations about implementation of "Registered Grower's Scheme" from the year 2009 till the date of filing the RTI petition dated 1-6-2016, The RTI application was transferred by the SPIO and Joint Secretary to the Govt. of Assam, Agriculture Department to the Managing Director of Assam Seeds Corporation Ltd. vide letter dated 10th June, 2016. Thereafter no action appears to have been taken by the concerned SPIO of Assam Seeds Corporation Ltd.

The Commission, therefore, directs the SPIO of Assam Seeds Corporation Ltd. to furnish the required information to the petitioner within 15 days from the date of receipt of this order.

With the above order the second appeal petition dated 19-12-2016 is disposed of.
