**O R D E R****25-1-2017**

The petitioner Sri Joydeb Das is present. The public authority is represented by :- (1) Sri Ramesh Ch. Medhi, SPIO and Manager, (Production), Assam Seeds Corporation Ltd. , and (2) Sri Mainul Haque Talukdar, ASPIO, Assam Seeds Corporation Ltd.

The second appeal petition dated 19-12-2016 is taken up for hearing in presence of both the parties in pursuance of this Commission's earlier order dated 30-12-2016.

The petitioner as well as the SPIO of Assam Seeds Corporation Ltd. both submitted orally that the subject matter of the instant appeal case is identical with the appeal case No. SIC/KP(M) 788/2016 with reference to a separate RTI petition dated 19-12-2016 filed by the same petitioner. Only the name of the Contracting Firms are different, the information sought for in respect of both the firms are identical. Hence appeal case No. KP(M) 788/2016 is clubbed together with the instant case.

The SPIO produced one huge file containing a pile of papers that contain the sought for information. He submitted orally that the file which was produced before this Commission contains the required information in respect of both the appeal cases.

This Commission, therefore, directs the petitioner to visit the office of the SPIO of Assam Seeds Corporation Ltd today itself or within seven days from the date of this order which was pronounced in presence of both the parties and take relevant copies of documents sought for by him free of cost up to 100 pages for both the appeal cases mentioned above.

With the above order both the second appeal petitions dated 19-12-2016 are disposed of.
